### SESSION 1 • KAYLA ROWSER, MASTER TEACHER • JULY 24 - JULY 28



Originally from Conyers, Ga., Kayla Rowser trained at the Magdalena Maury School of Classical Ballet in Fayetteville, Ga., with Georgia Youth Ballet under the direction of Magdalena Maury, Jonsie Pollock and Magda Aunon. She spent her summers studying with American Ballet Theatre, Atlanta Ballet and the Washington Ballet, among others. After graduating high school, Kayla joined Charleston Ballet Theatre for a season before joining Nashville Ballet's second company, NB2, in 2007. In her two years as a trainee, she performed with the main company in several series. Kayla joined the main company as an apprentice in 2009, where she performed as Zulme in *Giselle*, Balanchine's *Who Cares?* and Paul Vasterling's *Awaiting Redemption*. Since being promoted to company member in 2010, Kayla has performed as Snow Queen and Sugar Plum Fairy in *Nashville's Nutcracker*, Pas de Trois in *Swan Lake*, Cupid in Vasterling's *Carmina Burana* and in Salvatore Aiello's *Afternoon of a Faun*. She was featured as the title role in Nashville Ballet's 2012 performance of *Firebird*, as Aurora in *The Sleeping Beauty* and as Odette/Odile in *Swan Lake*. Kayla has also been seen as Tinkerbell in Vasterling's *Peter Pan*. In 2014, she performed in Vasterling's *The Ben Folds Project*, Eurydice in Vasterling's *Time/Return/Memory*, Russian Girl in Balanchine's *Serenade*, and Jiri Kylian's *Petite Mort*. Miss Rowser has most

recently been seen as Mina in Vasterling's *Dracula* and Fortuna in Vasterling's *Carmina Burana*. Kayla was featured as one of *Dance Magazine's* "Top 25 to Watch" in 2013 in addition to being featured in *Pointe Magazine* and on the *Huffington Post*. She enjoys teaching ballet to young students, and she has taught at local Nashville dance studios and throughout much of the Southeast. She also accepted an invitation to teach master classes at Yale University. Miss Rowser is currently working towards a degree in Communications and was awarded the Individual Artist Fellowship by the Tennessee Arts Commission in 2015.

### SESSION 2 • DEREK REID, MASTER TEACHER • JULY 31 - AUGUST 4



Derek Reid, Associate Professor of Dance, began his training at the Jones-Haywood School of Ballet in his native Washington, D.C. He subsequently studied in intensive programs with Rosella Hightower in Cannes, France, Milwaukee Ballet, Richmond Ballet and Butler University, from which he received a B.F.A. in Dance. Mr. Reid's professional dance career spanned fourteen years, during which time he performed with the Louisville Ballet, Pennsylvania Ballet, Dance Theatre of Harlem, Les Grands Ballets Canadiens and Ballet Met in Columbus, Ohio. He performed and created leading roles in works by such internationally acclaimed choreographers as Choo San Goh, William Forsythe, Jiri Kylian, Nacho Duato, James Kudelka, Mark Morris and Ohad Naharin. His repertoire ranged from the classical to the contemporary, as he performed roles as varied as the prince in *The Nutcracker* to roles in works by choreographic masters such as Antony Tudor, Vaslav Nijinsky, Irina Nijinska, Agnes de Mille, and George Balanchine. Mr. Reid's television credits include PBS's production of Dance Theatre of Harlem's *Fall River Legend*, choreographed by Agnes de Mille, as well as the Canadian Broadcasting Corporation's *Dancers for Lifegala*, in which he performed the pas de deux from Nacho Duato's *Rassemblement*. Another

highlight of his career was dancing Duato's *CorPerdutat* the Acropolis in Athens, Greece with the Gala des Etoiles. Prior to teaching at the Fort Wayne Ballet, Mr. Reid taught summer workshops at the Northwest Florida Ballet. His choreographic contributions at the Fort Wayne Ballet include *Ceremony*, *Jeux d'Enfants* and *The Firebird*. Mr. Reid teaches Ballet Technique and Dance History.
